
I am writing to officially welcome your agency to South Sound 911. Enclosed you will find your fully executed copy of your emergency dispatch agreement that has been assigned and accepted by South Sound 911. As you are aware, South Sound 911 is an interlocal administrative agency that was formed to integrate the six communications centers in Pierce County. While the integration continues to be a work in progress, an important step is the integration of Fife Dispatch into South Sound 911 operations. Through this process, your dispatch agreement was assigned to South Sound 911. The terms and conditions will remain unchanged for 2015. A new agreement directly with South Sound 911 will be required in 2016, and every effort is being made to ensure that costs are not significantly increased in the future for any of our customers.

Initially, the operational functions will remain the same with Fife dispatchers providing service from the location at the Fife Police Department. The physical transition of Fife Dispatch is expected to occur in 2015. All operations are anticipated to consolidate in the new Public Safety Communications Center to be constructed over the next two to three years. We have just selected a development team to commence the facilities project which, when complete, will house all dispatch operations.

South Sound 911 is committed to customer service and continuing to provide the level of service expected from your agency. AMENDMENT TO INTERLOCAL AGREEMENT FOR DISPATCH SERVICES
AUTHORIZING ASSIGNMENT OF SERVICES TO SOUTH SOUND 911

THIS AMENDMENT TO INTERLOCAL AGREEMENT is made and entered into this 2nd day of April, ~~2014~~²⁰¹⁵, by and between the City of Fife (“Fife”), City of Milton (“Milton”), and South Sound 911 (“SS911”).

WHEREAS, Fife operates a dispatch center; and

WHEREAS, Milton contracts with Fife for dispatch services; and

WHEREAS, Pierce County, the City of Tacoma, the City of Lakewood, the City of Fife, the City of Puyallup and Pierce County Fire Protection District NO. 3 (West Pierce Fire & Rescue) have created an interlocal agency called South Sound 911;

WHEREAS, SS911 was created to integrate dispatch services throughout Pierce County;

WHEREAS, Fife’s dispatch services are integrating into SS911 on January 1, 2015; and

WHEREAS, SS911 agrees to honor the dispatch agreement between Fife and Milton through at least 2015;

NOW, THEREFORE, in consideration of the mutual promises and covenants herein contained, it is hereby agreed as follows:

1. Effective January 1, 2015, Fife assigns to SS911 its rights and responsibilities under the Interlocal Agreement for Dispatch Services entered into between Fife and Milton dated November 14, 2006 and amendment on October 23, 2012, SS911 accepts the assignment and Milton consents to the assignment.
2. The SS911 Budget and Finance Manager shall serve as the administrator for the agreement. Any written notice as required by the Agreement shall be transmitted to:

3. On or before June 30, 2015, SS911 and Milton shall enter into a new contract for dispatch service that will commence January 1, 2016.
4. **Original Agreement in Full Force and Effect:** All other aspects of the original agreement remain in full force and effect except to the extent necessary to reflect the changes stated herein.



