The project will construct a new State Route (SR) 509 Spur alignment between SR 509 and Interstate 5 (I-5) and a new portion of SR 167 alignment between I-5 and 20th Street East, and associated riparian restoration and wetland mitigation within the cities of Tacoma, Fife, Milton, Edgewood, and Unincorporated Pierce County, Washington.
