**ORDINANCE NO. 1962-19**

AN ORDINANCE OF THE CITY OF MILTON, WASHINGTON, MAKING CERTAIN FINDINGS OF FACT AND AMENDING THE 2019 BUDGET ADOPTED WITH ORDINANCE NO. 1954-18 ON DECEMBER 3, 2018 AND PROVIDING FOR SEVERABILITY, AN EFFECTIVE DATE, AND FOR SUMMARY PUBLICATION BY ORDINANCE TITLE ONLY.

WHEREAS, the Milton City Council adopted the 2019 Budget with Ordinance No. 1954-18 on December 5, 2018; and

WHEREAS, the City Council has determined that it is in the best interest of the City of Milton to adjust the 2019 Budget by amending the Monthly Wage Scale; and

WHEREAS, the adjustments to the Monthly Wage Scale will not require additional funds in 2019; and

WHEREAS, this will not result in new ending fund balances for 2019; and

NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF MILTON, WASHINGTON, DO  
ORDAIN AS FOLLOWS:

Section 1. The above stated recitals are hereby adopted as the council's findings and reasons for the adoption of this ordinance.

Section 2. The 2019 Budget, as adopted with Ordinance 1954-18 is hereby amended with a new Monthly Wage Scale as detailed in the attached exhibit B – Proposed Wage Scale as Amended.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent

jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.


