

ORDINANCE NO. 1973-19

AN ORDINANCE OF THE CITY OF MILTON, WASHINGTON, ACCEPTING THE DONATION AND INSTALLATION OF 9/11 MEMORIAL AT MILTON COMMUNITY PARK; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Milton 9/11 Memorial Committee, a Washington nonprofit entity (9/11 Memorial Committee) has chosen the City of Milton as a recipient of the donation and installation of 9/11 memorial monument at Milton Community Park for the purpose of honoring the service, sacrifice and legacy of lives lost police and fire first responders; and

WHEREAS, in accordance with MMC 3.40.030, the City is allowed, by ordinance, to accept monetary and property donations; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF MILTON, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Donation Accepted. The City of Milton hereby accepts the donation and installation of a 9/11 memorial monument to be placed at Milton Community Park as set forth in the Milton 9/11 Memorial Donation and License Agreement, attached as Exhibit A.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.




